Achievements to 5 Oct



Following the official project launch in July 2019, the first tranche of funding was received in September 2019.

Technical Guidance Development update

Stakeholder Engagement update

- 18 <u>Country Champions</u> have been appointed in Afghanistan, Australia, Brazil, Colombia, China, Ethiopia, Ghana, India, Jamaica, Kenya, Nigeria, Rwanda, Turkey, Uganda, UK, USA, Zambia & Zimbabwe.
- 5 country Awareness meeting (Rwanda, Uganda, UK, India, Afghanistan) held since 17 Sep
- 3 members of the <u>Donor Reference Group</u> appointed to date. (Ford, OSF, Nippon Foundation)
- The Marketing & Communications Officer was appointed in January 2020. The project has active social media accounts with 522 <u>Linkedin</u> and 124 <u>Twitter</u> followers.
- The project <u>website</u> was launched in May 2020, including an online forum for the IFR4NPO community to interact. All the project meetings, papers, and advisors are easily accessible to ensure the development process is transparent.
- 8 blogs, articles have been published. 6 newsletters have been issued. 609 people from 87 (31 July figures) countries have subscribed to newsletters. One <u>explainer video</u> was published and others are in progress. 15 webinars, conference sessions, awareness meetings and podcasts have been presented.
- Stakeholder analysis conducted as part of full stakeholder engagement strategy.








Governance

• The project <u>Steering Group</u> was established, with their first meeting held in May 2020, and the final member appointed in September 2020.







Challenges

- Fundraising has been a challenge with donors focussed on COVID contingency plans discussed with Steering Group late September.
- Online forum functionality has had a problem, due to be rectified 9 Oct.
- Online meetings for the PAG and TAG have been challenging to make sure all voices are heard and issues adequately explored.
- Behind schedule with Country Champion recruitment (target 21, so far only 18)
- Target for newsletter and forum registrations is 2000 (currently 609)





